**Applications are invited from Unmarried Eligible Graduate Engineers for admission to Graduate Marine Engineers (GME) Course at SCI's Maritime Training Institute, Powai, Mumbai, scheduled for commencing from 1<sup>ST</sup> May 2023.**

As a National Carrier and the country's premier shipping line, The Shipping Corporation of India (SCI) owns and operates around half of the Indian tonnage, and has operating interests in practically all areas of the shipping business; servicing both national and international trades.

In view of the demand from Indian and International trade, SCI has diversified into a large number of areas. Today, SCI is the only Indian shipping Company operating Tankers, Product Carriers, International container services, Liquid/dry bulk services, LPG & LNG, Offshore services, Passenger services. In addition, SCI does the manning and manages a large number of vessels on behalf of various government departments and organizations.

**ABOUT GME COURSE:**

GME course is conducted by SCI's Maritime Training Institute (SCI -MTI) at Powai, Mumbai. This course is approved by Directorate General of Shipping (DGS). GME course comprises of pre-sea training of 08 months at MTI Powai, Mumbai and total structured shipboard training of 10 (4+6) months thereafter on ships operated by SCI.

**JOB PROSPECTS:**

After completion of 08 months shore training as GME and total 10 (4+6) months structured shipboard training as GME, candidates can appear for Marine Engineer Officer (MEO) CLASS-IV PART "A" and MEO CLASS IV PART "B" examination for issuance of Certificate of Competency (COC) by Directorate General Of Shipping (DGS). However, as per DGS guidelines, the candidates holding Degree in Mechanical Engineering and Marine Engineering streams are exempted from appearing in DGS examination of MEO CLASS-IV PART "A" and they will directly undergo MEO Class-IV, Part-B examination upon satisfactory completion of total 18 (12 + 6) months training period. On completion of satisfactory performance of training period and after passing DGS examinations of MEO Class -IV , Part-A (as applicable) and MEO Class-IV, Part-B and holding COC for MEO Class- IV , SCI will employ these candidates as a regular SCI employees ,on ships owned, manned or operated by SCI as per INSA - MUI Agreement ,

provided candidates must join SCI ships within 18 months from signing off from only their last SCI ships. Also candidates will be required to furnish an indemnity bond to SCI for agreeing to serve on SCI vessels for a period of 5 years after obtaining the MEO CLASS IV PART B certificate of competency. In the event of breach of Indemnity, candidate shall be liable to pay Rs. 3.00 Lakhs towards the expenses incurred on the skill development. After obtaining necessary sea experience and higher certificates of competency the candidate can rise to the rank of Chief Engineer officer on the ship.

### **ELIGIBILITY:**

As per DGS guidelines, the following categories are eligible to undertake the admission for pre-sea Training of 8 months shore training by SCI-MTI.

- (I) Category (a) - A full time BE / B. Tech in Engineering streams e.g. Mechanical and
- (II) Automation , Mechanical and Electronics, Mechanical and Automobiles etc. However, the word “ Mechanical “should be first indicating that mechanical engineering is the core and the second subject is the elective with minimum 50% marks in final year of Engineering Degree
  
- (III) Category (b) - All Naval Architecture streams e.g. Naval Architecture and Ocean Engineering, Naval Architecture and Ship building etc. However, the word “Naval Architecture” should be first indicating that Naval Architecture is the core and the second subject is the elective with minimum 50% marks in final year of Engineering Degree.
  
- (IV) Category (c) - BE /B. Tech in Marine Engineering with minimum 50% marks in final year of Engineering Degree
  
- (V) Category (d) – BE/B. Tech in Mechanical Engineering with minimum 50% marks in final year of Engineering Degree
  
- (VI) Other Higher degree such as 5 year integrated ME/M tech in above all categories with minimum 50% marks in final year of Engineering Degree

The candidates must have been obtained Engineering Degree of above categories from AICTE approved institute or from IIT or from Engineering colleges /University recognized or approved by State or Central Government. Equivalent degree or degree with specialization or electives other than above educational qualification is not acceptable. Candidates must be in possession of valid Engineering degree certificate / provisional degree certificate/ Marks Sheet with minimum 50% marks in final year of Engineering at the time of interview. Furthermore, candidates should have secured at least 50% marks in English language at Xth or XIIth class or in a degree course.

Candidates who are natives of Lakshadweep and Andaman & Nicobar islands and belong to scheduled tribe and also who and both of whose parents were born in those islands and belong to Scheduled Tribes have been given relaxation of 5 percent (%) marks in “English” language in the X th or XII th class or in degree exam.

Candidates from the combined streams i.e. category (a) and (b) will have to pass DGS Examinations of Part “A” subjects of both MEO Class IV and MEO Class –II grade,. whereas candidates from category (c) and (d) are exempted from appearing in all subjects of Part “A” of both MEO Class IV and MEO Class II grade of examinations.

SCI-MTI shall not be held responsible for candidates found NOT eligible by Directorate General of Shipping to appear in MEO Class IV , Part A / Part B examination. No refund of GME course fee will be done in this case by SCI-MTI.

**AGE LIMIT:**

Maximum 28 years as on 1st May 2023. Age relaxation of up to 5 years applicable to SC and ST candidates and 03 years for OBC (Non-Creamy Layer) candidates as per the Directorate General of Shipping, India. **Age relaxation of two years for female candidates is applicable.**

**NO. OF SEATS : Total 40 nos. of GME course seats are distributed as follows,**

General / Unreserved (UR)-16, Economical weaker Section (EWS) – 04, Other Backward Caste with Non Creamy Layer category (OBC-NCL) -11, Schedule Caste (SC)-06, & Schedule Tribes (ST)-03

**COURSE FEES:**

The fees for training are **INR 5,25,000/- (INR Five lakhs and Twenty Five Thousand only)** for male candidates and **INR 4,50,000/- (INR Four lakhs and fifty thousand only)** for female candidates. Candidate will pay fees to the SCI-Maritime Training Institute (SCI MTI), Powai, Mumbai. Fees once paid are not refundable at any stage either in full or part. Consolidated stipend of Rs. 15000/- (INR Fifteen Thousand only) per month will be paid to candidates for structured shipboard training. No stipend will be paid to candidates during shore based 08 months training by SCI-MTI.

**MEDICAL STANDARD:**

Candidate must have good health and be fit for sea service as per existing MS Medical rules 2000/MLC 2006 applicable to seafarers.

Note: Medical fitness check will be done through SCI empanelled DG approved Doctors and **No waiver will be given for the above standard.** Candidates not meeting the above standard should not apply. Medical examination fees shall be borne by the candidates.

**PRIOR PERSONAL INTERVIEWS, CANDIDATES SHOULD POSSESS VALID INDIAN PASSPORT. WITHOUT VALID INDIAN PASSPORT, CANDIDATES SHALL NOT BE GIVEN ADMISSION TO GME- 11 COURSE.**

Candidates who are not possessing valid Indian passport are advised to apply for new passport in “TATKAL” mode, if possible.

**SELECTION CRITERIA:**

Eligible candidates will be permitted to appear in the physical test at examination centers at Delhi, Mumbai , Kolkatta and Chennai at their own expenses and only candidates qualifying in the on line test will be called for Personal Interview in the ratio of 1:3 (3 candidates called against 1 vacancy); keeping the provision of reservation for SC,ST,OBC (NCL) and EWS. The Shipping Corporation of India Ltd. reserves the right to shortlist the candidates for online test and for personal interviews

without issuing any further notice or assigning any reasons thereof.

**APPLICATION FEES:**

- Rs.1000 /- (Rs. One Thousand Only) for General (UR), EWS & OBC (NCL) candidates.
- Rs.500/- (Rs. Five Hundred only) for SC, ST and Female candidates.
- Without application fees, the online application of candidate will not be accepted.
- The above Application Fees are non-refundable.

**INTERVIEW SCHEDULE:**

List of candidates shortlisted for interview will be published on SCI- MTI Website <http://www.mti.shipindia.com/notification>. The personal interviews of candidates will be conducted virtually or physically as applicable. Similarly, the final list of selected candidates prior Medical Fitness Test will be published on the above website and / or their respective Emails and only be intimated about the joining date and other formalities. The Shipping Corporation Of India Ltd. reserves the rights to cancel or change the process including the dates of Personal Interviews without issuing any further notice or assigning any reasons thereof.

**SELECTION PROCEDURE, ONLINE EXAMINATION INCLUDING INTERVIEW SCHEDULE:**

- a) The online examination will be conducted tentatively on 23.04.2023 at 1030 hrs. Expenses incurred in online examination shall be borne by candidates.
- b) Shortlisting criteria will be based on higher percentage of marks obtained in online examination.
- c) The online examination will be objective type, which will cover the subjects such as Professional Knowledge, English Language, Quantitative Aptitude and Reasoning Ability.
- d) The Shipping Corporation of India Ltd. reserves the rights to cancel or change the examination venue / place/ date and process without issued any further notice or assigning any reasons thereof.
- e) The personal interviews of candidates will be conducted physically as applicable tentatively in the month of April/May 2023. All selected candidates are required to appear for the personal interview at their own expenses. The details about the actual interview schedule will be communicated to all eligible candidates through our websites and Emails in due course of time, keeping the provision of reservation for SC, ST, OBC (NCL) and EWS category.
- f) Only candidates qualifying in both online examination and the personal interviews are required to undergo Medical Fitness test by DGS approved Doctors. The all expenses for Medical Fitness Test shall be borne by candidates. The Shipping Corporation of India Ltd. reserves rights to nominate the doctors for medical fitness test of candidates, if required.

**Note: The final list of selected candidates will be published on the SCI-MTI website and/or candidates will be intimated through emails about the Medical examination and joining date and other formalities in due course.**

## HOW TO APPLY:

- 1) Online applications for GME course will be accepted online only from **20.03.2022 /0001 Hrs to 10.04.2023 / 2359 Hrs**, Candidates are requested to logon to <https://onlineapply.ind.in/> for filling the online application form and online payment of examination fee.

- 3) The application fee of **INR 1000/- (INR One Thousand)** for General (UR ), OBC (NCL) and EWS candidates And **INR 500/- for SC, ST and female** candidates.
- 4) Eligible candidates to apply only in online mode. It is mandatory that the candidates should have a valid E-mail ID and mobile number while applying in order to facilitate faster communication. All future communication and correspondence will be made through emails and / or SCI-MTI official website
- 5) Detailed instructions for filling up the application form will be given under the “General Instructions” Candidates should carefully read all instructions before submitting application form.
- 6) Before applying, candidates should ensure that they fulfill all the eligibility criteria and norms mentioned in this advertisement.
- 7) Upon saving the on-line application with the registration number, candidate has to download the printout of application form. Candidates are advised to download and keep one copy each of application form and bank transaction fee receipt with him/her. These copies will be required for submission at the time of personal interview during documents verification, if qualified in the online examination.
- 8) Filling of multiple applications will result in cancellation of all applications.

## GENERAL INFORMATION AND INSTRUCTIONS:

- Only Indian Nationals are eligible to apply.
- ***An application fee once deposited is NOT refundable in any circumstance.***
- ***Candidates should have valid Indian Passport as same is required to generate INDos Number in DGS website prior admission to course.***
- If any information provided by the candidate is found to be false or incorrect or not in conformity with the eligibility criteria, then his / her candidature is liable to be rejected at any stage of the selection process or after selection or joining or after completing onboard training.
- No modifications are allowed after submission of the application form. Incomplete application form in any particulars is liable to be rejected. Write “NA” for whichever is not applicable.
- Candidature is also liable to be rejected if the online application forms received unsigned or without correct photo or received with wrong application fee or received without application fees and received after the last date of receipt of applications.
- Candidates employed with Government departments / PSUs / Autonomous bodies have to produce NOC at the time of interview if called for the same. If such candidates cannot provide the NOC, they will not be allowed to appear for the interview.
- The Shipping Corporation of India Ltd. reserves the right to change the number of vacancies and cancel / restrict / modify / alter the selection process, if required, without

- **Candidates must complete Engineering Degree prior the date of Personal Interview. No Candidates will be selected without completion of Engineering Degree Course.**
