## Applications are invited for admission to Trainee Electro Technical Officer (ETO) Course at Maritime Training Institute (MTI) at Powai, SCILAL, Mumbai, commencing from Oct- 2023.

SCILAL Ltd. i.e. Shipping Corporation of India Land and Assets Limited is an demerged company of The Shipping Corporation of India Limited. Maritime Training Institute Powai is an institute under SCILAL under Ministry of Ports, Shipping and Waterways.

As a National Carrier and the country's premier shipping line, The Shipping Corporation of India Ltd. (SCI) owns and operates around one third of the Indian tonnage, and has operating interests in practically all areas of the shipping business; servicing both national& international trades.

To fulfill the demand of Indian& International trade, SCI has diversified fleet of Crude oil Tankers, product tankers, Dry bulk carriers, container vessels, LNG and LPG ships, passenger ships, offshore vessels including AHT,PSV, MSV and MODU. SCI is also having O&M contract with various Government departments and Organizations.

#### **ABOUT ETO COURSE:**

Pre sea training of Electro Technical Officer (ETO) course is conducted at Maritime Training Institute at Powai, SCILAL, Mumbai. This course is approved by Directorate General of Shipping (DGS). ETO course comprises of pre-sea training of 04 months at MTI, Powai, SCILAL, Mumbai and structured shipboard training of 08 months thereafter on ships operated by SCI.

# **JOB PROSPECTS:**

After completion of 04 months pre sea training at shore and 08 months structured shipboard training as trainee ETO, candidates can appear for an examination conducted by D.G. Shipping, Government of India for issuance of "Certificate of Competency (COC)" for the rank of Electro Technical Officer. On satisfactory completion of training period of 12 (4 + 8) months by a Trainee ETO cadet and there after qualifying the examination of D G Shipping, Government of India with the possession of COC of ETO rank, Shipping Corporation of India Ltd. (SCI) may employ those candidates on ships owned, manned or operated by SCI as per INSA MUI Agreement, subject to availability of vacancies. Also, candidates will be required to furnish an indemnity bond to SCI for agreeing to serve on SCI vessels for a period of 5 years after obtaining the certificate of competency (COC) of ETO. In the event of breach of Indemnity, candidate shall be liable to pay INR 3, 00,000.00 (INR Three Lakh) towards the expenses incurred on the skill development.

## ELIGIBILITY:

### AA) Candidates should have the following educational/academic qualification

 (a) Passed Four Year's B.E./B. Tech Degree including lateral entry, with 50% marks in Electrical Engineering, Electronics Engineering, Electrical and Electronics Engineering, Electronics and Telecommunication / Communication Engineering, or Electronics and Instrumentation or equivalent.

(b) The candidates must have secured minimum 50% marks in English in 10th or 12th standard exams. If a candidate could not secure 50% marks in English in 10th or 12th standard exams shall still be eligible provided the candidate secures 50% in the degree examination and the medium of learning in degree was English.

**Note** - The candidate must have passed the 10th and 12th standard from a recognized board. The degree courses must be recognized by any state or central Government or the AICTE.

#### OR

2. (a) The Candidates who were admitted in Three Years Diploma course on the basis of Matriculation only and went to complete their B.E. / B. Tech degree course as a lateral entry in the 2nd year of the degree on the basis of Diploma, and has secured with 50% marks in Electrical Engineering, Electronics Engineering, Electronics and Telecommunication / Communication Engineering, or Electronics and Instrumentation or equivalent.

(b) The candidates must have secured minimum 50% marks in English in 10th standard exams. If a candidate could not secure 50% marks in English in 1 th standard exam shall still be eligible provided the candidate secures 60% marks in Diploma or 50 % marks in the degree exam and the medium of learning in diploma or degree was English.

**Note** - The candidate must have passed the 10th standard from a recognized board. Three Years diploma and degree courses must be recognized by any State or Central Government or the AICTE.

OR

 (a) Passed three years' Diploma with 60% marks in Electrical Engineering Electronics Engineering, Electrical and Electronics Engineering, Electronics and Telecommunication / Communication Engineering, or Electronics and Instrumentation or equivalent.

(b) The candidates must have secured minimum 50% marks in English in 10th standard exams. If a candidate could not secure 50% marks in English in 10th standard examination, shall still be eligible provided the candidate secures 60 % in Diploma exam and the medium of learning in diploma was English.

**Note-l.** The candidate must have passed the 10th standard from a recognized board. Three Years diploma must be recognized by any State or Central Government or the AICTE

#### **BB) Age Limit:**

The maximum age limit for candidates shall be of 30 years as on 30.10.2023. Maximum age relaxation of 3 years is applicable to Other Backward Class- Non Creamy Layer (OBC-NCL) and 05 years of age relaxation of Scheduled Caste and Scheduled Tribe candidates as per the directives of Government of India. **Age relaxation of two years will be applicable to female candidates.**

#### **COURSE FEES:**

The fees for training are **INR 4, 30,000.00/- (INR Four Lakh Thirty Thousand only)** for male and **INR 3,80,000.00/- (INR .Three Lakh Eighty Thousand only)** for female candidates. Candidate will pay fees to Maritime Training Institute, Powai, SCILAL, Mumbai. Fees once paid are not refundable at any stage either in full or part. Consolidated stipend of **INR 10,000/- (INR Fifteen Thousand only)** per month will be paid to candidates for structured shipboard training.

No stipend will be paid to candidates during shore based training.

#### **MEDICAL STANDARD:**

Candidate must have good health and be fit for sea service as per existing MS Medical rules 2000/MLC 2006 applicable to seafarers. Medical fitness check & Psychometric test will be done only through Directorate General of Shipping's (DGS) approved Doctors. **No waiver will be given for the above standard.** Medical examination fees shall be borne by the candidates.

#### **SELECTION CRITERIA:**

Eligible candidates will be required to appear physically at any one of the examination centers located at Delhi, Mumbai, Kolkata and Chennai. All expenses for appearing in the examination have to be borne by candidates. Candidates qualifying in the examination will be called for physical Personal Interviews in the ratio of 1:3 (3 candidates called against 1 vacancy) keeping the provision of reservation for SC, ST, OBC –NCL & EWS category. Maritime Training Institute, Powai, SCILAL Ltd., Mumbai reserves the right to shortlist the candidates for the examination and personal interviews without issuing any further notice or assigning any reason thereof.

#### **ABOUT THE EXAMINATION:**

The written examination shall be of two (02) hours duration, which will be in the form of multiple choice questions (MCQs). The examination will focus on Professional Knowledge test, English Language test, Quantitative Aptitude test and Reasoning Ability test. The questions of the test will be bilingual (English and Hindi). The passing Marks in each test will be decided on the basis of the performance of all the competing candidates in each test. The details of online examination will be informed to only ELIGIBLE candidates. The candidates who does not possess the valid documents and passed in examination shall not be invited for personal interviews. **The Shipping Corporation of India Land and Asset Ltd**. reserves the right to cancel or change the examination procedures or criteria including time schedule without issuing any further notice or assigning any reasons thereof.

#### **EXAMINATION CENTRES:**

The examination will be held at Mumbai region, New Delhi, Kolkata, and Chennai only. Candidates will have to choose a test center of their choice and the same cannot be changed after submission of online application form. However, **The Shipping Corporation of India Land and Asset Ltd** reserves the right to cancel or add any test center or change the center chosen by the candidates without issuing any further notice or assigning any reasons thereof.

#### SELECTION PROCEDURE, EXAMINATION AND INTERVIEW SCHEDULE:

- a) The examination will be conducted tentatively on 08.10.2023 (Sunday) at 1030 hrs. Expenses incurred in online examination shall be borne by candidates..
- b) Short listing criteria will be based on higher percentage of marks obtained in examination.
- c) The examination will be of objective type, which will cover the subjects such as Professional Knowledge, English language, Quantitative Aptitude and Reasoning Ability.
- d) The Personal Interviews of candidates will be conducted physically in the month of October 2023. All selected candidates are required to appear for the interview at their own expense, as applicable. The details about the actual Interview schedule will be communicated to all eligible candidates through our website and/ or Emails in due course of time, keeping the provision of reservation for SC, ST, OBC –NCL and EWS categories.
- e) Only candidates qualifying in both examination and the personnel interviews are required to undergo Medical Fitness test by only DGS approved Doctors.. The all expenses for medical examination shall be borne by the candidates. The Shipping Corporation Of India Ltd. reserves rights to nominate the Doctors, if required, for the STCW medical fitness test of the candidates.

INDOS number is required to update the name and details of candidates in Directorate General of Shipping's website. Without updating the details of candidates in DGS website, the admission procedure to ETO course shall not be commenced. Candidates who do not possess valid Indian passport are requested to initiate process of generating passport at the soonest or if required in 'TATKAL' mode also.

- 2. Only Indian Nationals are eligible to apply.
- 3. An application fee once deposited is NOT refundable in any circumstance.
- 4. If any information provided by the candidate is found to be false or incorrect or not in conformity with the eligibility criteria, then his / her candidature is liable to be rejected at any stage of the selection process or after selection or joining.
